CIRCULAR

Sub: Release of Composite School Grant to Govt. Schools through e-transfer for the year 2022-23 - Guidelines issued – Reg

The Composite School Grant under Samagra Shiksha is released through e-transfer to the Government Schools in the UT of Puducherry for the year 2022-23 as detailed below.

- @ Rs.10,000/- per school for enrolment up to 30 students.

 (Including at-least Rs.1,000 for Swachhta Action Plan)
- @ Rs.25,000/- per school for enrolment from 31 to 100 students.

 (Including at-least Rs 2,500 for Swachhta Action Plan)
- @ Rs.50,000/- per school for enrolment from 101 to 250 students.

 (Including at-least Rs.5,000/- for swachhta Action Plan)
- @ Rs.75,000/- per school for enrolment from 251 to 1000 students. (Including at-least Rs.7,500/- for Swachhta action Plan)
- @ Rs.1,00,000/- per school for enrolment Students 1001 and above. (Including at-least Rs.10,000 for Swachhta action Plan)

The guidelines for utilization of Composite School Grant are given overleaf. The Heads of Schools are instructed to get entries made in the passbook, to confirm the ECS payment to their bank accounts, and utilize the funds for the purpose for which it is granted. Further, it is requested to ensure that the funds are spent through the respective School Management Committee / School Management and Development Committee.

GUIDELINES FOR UTILIZATION OF COMPOSITE SCHOOL GRANT

The Composite School Grant may be utilized for:

- 1. The replacement of non-functional school equipments.
- For incurring other recurring costs, such as consumables, play materials, games, sports equipments, laboratories, electricity charges, internet, water, teaching aids etc.
- 3. To provide annual maintenance and repair of existing school buildings, toilets and other facilities to upkeep the infrastructure in good condition.
- 4. To Promote Swatch Bharat campaign.
- 5. Must involve elements of community contribution.
- 6. There must be transparency in utilization and provision of funds for social audit.
