NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, read with the Notification No. F. 5/4/65-GP, dated the 11th January 1965 of the Ministry of Home Affairs, Government of India. New Delhi and in supersession of the notification issued in G.O. Ms. No. 60, dated 5th August 1992 of the Department of Personnel and Administrative Reforms (Personnel Wing) and the Schedule annexed thereto and published in the Supplement to the Gazette No. 35, dated the 1st September 1992, save as respects things done or omitted to be done before such supersessions, which is necessitated consequent on the implementation of the Central Civil Services (Revised Pay) Rules, 2008, the Lieutenant-Governor, Puducherry hereby makes the following rules regulating the method of recruitment to the Group 'C' post of Caner in various Departments of Government of Puducherry, namely:

- 1. Short title and commencement.—(1) These rules may be called the Government of Puducherry, Caner (Group 'C' post) Recruitment Rules, 2014.
 - (2) They shall come into force on and from the date of their publication in the official gazette.
- 2. Number of post, its classification and Pay Band and Grade Pay / Scale of Pay.— The number of the said post, its classification and Pay Band and Grade Pay/Scale of Pay attached thereto, shall be as specified in columns (2) to (4) of the Schedule annexed hereto.
- 3. Method of recruitment, age-limit and other qualifications.— The method of recruitment to the said post, age-limit, qualifications and other matters relating thereto, shall be as specified in columns (5) to (13) of the said Schedule.
 - 4. Disqualifications.— No person,
 - (a) Who has entered into or contracted a marriage with a person having a spouse living: or
- (b) Who having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Lieutenant-Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

- 5. Power to relax.— Where the Lieutenant-Governor is of the opinion that it is necessary or exped ent so to do, he may by order, and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
- 6. Saving.—Nothing in these rules shall affect the reservations, relaxation in upper age-limit and other concessions required to be provided for the scheduled castes, the scheduled tribes and other special category of persons in accordance with the orders issued by the Government from time to time in this regard.

The maximum age-limit for appointment by deputation shall be "not exceeding 56 years" as on the closing date of receipt of applications).
