Sub: DSE – Estt-III – Filling up of the vacant post of HM (P) of Primary Schools by promotion – Consideration of Primary School Teachers for promotion – Willingness of the PSTs & Service Particulars of the eligible candidates called for.

It is proposed to consider the Primary School Teachers who have completed 5 years of continuous service after appointment in the grade on regular basis for promotion to the post of Headmaster/Headmistress (Primary).

- 2. In this regard, the Primary School Teachers who have been recruited up to the year 2005 and are regularized in the post are requested to submit their Willingness/Unwillingness for promotion to the post of HM (Primary) as in Annexure through their Head of Office on or before 25/05/2018 without fail. In order to consider all the eligible candidates it is mandatory to all the PSTs recruited as PST up to the year 2005 to submit and confirm their willingness/unwillingness. Declining of promotion at the time of issue of promotion Order will not be entertained.
- 3. The Inspecting Officers/Heads of Offices concerned shall ensure that the contention of this Circular are brought to the notice of all the PSTs recruited up to the year 2005 and working under their control as on date. In cases of any specific individual(s) who are unauthorizedly absent from service, on EOL beyond the period of leave granted, demised, voluntarily retired, resigned, etc., a specific certificate must be furnished by the concerned Inspecting Officer/Head of Office. The willingness/unwillingness of the PSTs as in annexure and other service particulars of eligible PSTs in Proforma I (both Hard & Soft copies) must reach this directorate on or before 31/05/2018.
- 4. The eligible PSTs whose service particulars are not furnished would not be considered for future promotion/conferment of MACP etc. The Inspecting Officers/Heads of Offices concerned would be held responsible for any such lapses.
