NOTE: Candidates who are in possession of Bachelor's Degree / Post Graduate Degree in different names in the subjects / disciplines may also apply provided that they should submit necessary Equivalence Certificate obtained from the Universities concerned that the Post Graduate Degree(s)/ Bachelor's Degree(s) awarded to them is/are equivalent to the Degree(s) specified above in the relevant subjects/ language along with the application, if available. If not available, it should be produced at the time of certificate verification, failing which their names will be deleted from the Empanelled lists.

4) Cutoff date for certificates:

The certificates of Educational / Professional qualifications issued up to **26.11.2018** only, which is the last date for receipt of online applications, will be taken into account.

5) Nativity/ Residence & Community certificates:

Those who are natives of Karaikal region and residents by continuous residence in Karaikal region for the last five years immediately preceding the date of notification only are eligible to apply for the requirement. The Certificate should have been issued within one year from the date prescribed in the notification as last date for receipt of application by an officer of the Department of Revenue and Disaster Management, Govt. of Puducherry not below the rank of Deputy Tahsildar. The applicants may upload copies of the Nativity/Residence and Community Certificates (OBC/SC) along with their online application, if obtained afresh. Otherwise, copies of the available certificates may be uploaded. However, fresh Nativity/Community certificates, as required should be produced at the time of certificate verification, failing which their names will be deleted from the empanelled lists.

Candidates claiming reservation under SC category should belong to a caste which is recognized as Scheduled Caste under " The constitution (Pondicherry) Scheduled Castes Order, 1964 ", dated 05.03.1964 read with " The Constitution (Scheduled Caste) Orders (Second Amendment) Act, 2002 (Central Act 61 of 2002). The Community Certificate should have been issued within one year from the date prescribed in the notification as last date for receipt of application by an Officer of the Department of Revenue and Disaster Management, Govt. of Puducherry not below the rank of Deputy Tahsildar. The copy of the Certificate may be uploaded along with the application, if obtained afresh. Otherwise, copy of the available certificate may be uploaded. However, fresh Communicate certificate, as required should be produced at the time of certificate verification, failing which their names will be deleted from the empanelled lists.

NOTE: Empanelment of eligible candidates for all the cadres will be region-wise. Hence, candidates having residence in Karaikal region will alone be considered for the requirement notified. However, if sufficient eligible candidates are not available for any cadre/subject/category notified, then the eligible candidates available in Puducherry region for the particular cadre/subject/category will be considered based on the merit -cum- reservation provided that they should give a declaration to the effect that they are willing to be considered for being engaged in Karaikal region.

6) Persons with Disability (PwD):

The candidates with disability of 40% or more will be empanelled under the quota. They should necessarily submit the Medical certificate issued by the District Medical Board, Govt. of Puducherry. The Certificate should have been issued within 3 years from the date prescribed in the notification as last date for receipt of application. No other Certificate other than the above will be considered. The categories of disabilities suitable for the engagements are as follows:

- 1) One Arm, 2) One Leg, 3) Both Legs, 4) One Arm & One Leg,
- 5) Blind and 6) Low Vision

The Differently abled candidates applied for the requirement of Guest Trained Graduate Teacher (Subjects) / Guest Lecturer, irrespective of the Subjects/Disciplines/categories (OH/VH) will be listed according to their combined merit and based on which the candidates to the extent required will be empanelled.



7) Method for empanelment

The empanelment for Guest Primary School Teacher (For French Medium Schools)/Guest Trained Graduate Teacher (Subjects) will be based on marks obtained in the Teachers Eligibility Test (90% weightage) and Employment Exchange Seniority (10% weightage).

For Guest Bala Sevika, Guest Computer Instructor and Guest Lecturer, it will be based on the marks obtained in the open competitive examination (90% weightage) and Employment Exchange Seniority (10% weightage)

8) Weightage for Employment seniority:

The maximum marks shall be 10 at the rate of one mark for every completed year of registration in the Employment Exchange in the Union Territory of Puducherry subject to a maximum period of ten years to be counted backwards from the last date for receipt of online application. While computing the marks, the seniority should be reckoned as follows:

- 1) For Guest Balasevika, the seniority shall be reckoned from the date of Registration of Higher Secondary or Balasevika Training Certificate / Diploma / certificate in Early Childhood and Care Education, whichever is later.
- 2) For Guest Primary School Teacher (For French Medium Schools), the seniority shall be reckoned from the date of registration of D.T.Ed.
- 3) For Guest Trained Graduate Teacher (Subjects), the seniority shall be reckoned from the date of registration of Bachelor's Degree in the respective Language/Subject or B.Ed. or B.T., whichever is later.
- 4) For Guest Computer Instructor, the seniority shall be reckoned after three years from the date of registration of Bachelor's Degree or from the date of registration of Master degree, whichever is advantageous;
- 5) For Guest Lecturer, the seniority shall be reckoned from the date of registration of Post graduate Degree in the respective discipline or B.Ed. or B.T., whichever is later.



9) Written Examination:

The empanelment of **Guest Bala Sevika, Guest Computer Instructor and Guest Lecturer** will be made through a Competitive Examination. The written test will be one paper as follows:

NOTE: The empanelment of candidates applying for requirement as Guest Balasevika under MSP quota will be based on their achievements in the sports as per rules in force. There will be no written examination for the candidates under MSP quota. However, they may also participate in the written examination along with the other candidates if they are within the age limit under the category to which they belong to.

The Question papers will be of objective type having 90 questions carrying one mark for each question with a duration of 2 hours. **Negative mark of 0.25 will be awarded for every wrong answer and multiple answers will be treated as a wrong answer.** Candidates are, therefore, advised to keep this aspect in mind while answering the questions. Answering would be in the form of shading the correct answer by using **BLACK BALL POINT PEN** only. Merit list will be drawn based on the marks obtained by the applicants in the Competitive Examination and the weightage for Employment Exchange seniority. **The Competitive Examination centre will be in Puducherry only. The exact date, time and venue of the examination will be intimated in due course** in the official website of the Department/through Press Note.

10) Terms and conditions for being engaged as Guest Balasevika/Guest Teachers on contractual basis

1. The empanelled candidates, as and when necessity arises, will be engaged as Guest Teachers only for the particular academic year purely on contractual basis.
2. It will be purely a stopgap arrangement for the particular academic year or until the posts are filled on regular basis, whichever is earlier.
3. The Guest Teachers will be disengaged with the commencement of annual vacation and the engagement will come to an end.

4. The Guest Teachers may be re-engaged after re-opening of Schools, if necessity arises for continuing the arrangement, subject to their satisfactory performance in the previous academic year, with the approval of the Secretary to Govt. (Edn). However, no re-employment will be made beyond three years.
5. The Guest Teachers will be paid a fixed monthly wages as follows:
 - a) **Guest Balasevika and Guest Primary School Teacher (For French Medium School)** : ₹18,000/- per month
 - b) **Guest Trained Graduate Teacher (Subjects)** : ₹ 22,000/- per month
 - c) **Guest Computer Instructor and Guest Lecturer** : ₹ 25,000/- per month
6. The engagement will be on no work-no wage basis.
7. They are not entitled to any allowances like DA, HRA, Transport Allowance etc. or Bonus
8. They are not entitled to regularization of service against any post based on their service as Guest Teacher.
9. They are not entitled to regular leave of any kind. They are however entitled to public holidays and declared holidays. They are also entitled to one day casual leave for each completed month of service.
10. They are not entitled to any retirement or other terminal benefits of any kind.
11. The service rendered by the Guest Teachers shall not be reckoned for the purpose of seniority or for any other service benefits under the Government in future.
12. The services of the Guest Teachers may be terminated after issue of one month notice if their services are not up to expected standard or for any other specific reasons.
13. They may discontinue their services after giving one month notice if they do not want to continue.
14. They shall enter into an agreement with the Director of School Education in the prescribed format after which only engagement order will be issued.

11) How to Apply

Candidates who have fulfilled the above conditions may apply online only through the official website <http://schoolednpdyguestteacher.in> from 11.00 A.M. on 01.11.2018 to 5.00 P.M. on 26.11.2018.

12) General Instructions to the candidates before filling up of the online application.

1. The candidate should apply **through online only**.
2. Candidates having residence in Karaikal region should alone apply for the requirement notified in that region.
3. For Guest Balasevika, female candidates alone should apply.
4. Separate applications should be submitted if the candidates desire to apply for more than one requirement.




5. Avoid registering multiple online applications for a particular requirement. Such multiple applications will be cancelled.
6. **Photograph & Signature uploading:** Applicants are instructed to scan their recent passport size colour photograph, signature and the following documents with 150 dpi resolutions in JPG/JPEG image file format [maximum file size:150 kb] before starting online registration.
 - i. SSLC or its equivalent, Brevet Elementaire de Francais and HSC Certificates.
 - ii. Bachelor's Degree, Post Graduate Degree, B.Ed. or B.T., D.T.Ed, Teacher Eligibility Test Certificate, Bala Sevika Training Certificate **OR** one year Certificate or Diploma in Early Childhood Care and Education (ECCE) Certificates, etc. as the case may be and equivalency Certificate, wherever necessary.
 - iii. Birth Certificate / certificate in proof of Date of Birth
 - iv. Employment Exchange Registration Card.
 - v. Residence/Nativity certificate
 - vi. Caste Certificate (for SC/MBC/EBC/OBC/BCM/BT candidates only)
 - vii. Disability Certificate (for Person with Disability only) issued by Medical Board
 - viii. Meritorious Sports Person Certificate (for MSP candidates only)

7. The applicants have to register with his/her name, email ID, mobile number and their choice of Password in the online portal <http://schoolednnpdyguestteacher.in>. They will receive One Time Password (OTP) through email and the same should be entered in the online portal to proceed further.
8. It is the applicant's responsibility to take ownership of the password and it should not be disclosed to anyone. Otherwise, the liabilities arise upon will be the applicant's risk.
9. The applicants should ensure that the details furnished in the online application are correct and complete in all aspects and they fulfill the eligibility conditions as per the notification.
10. The applicants will be allowed to view and print their application. The data entered in the application and **saved** can be edited / corrected, if needed at any point of time before final submission. **However, application once submitted cannot be corrected /altered thereafter.** Hence, the applicants are advised to verify the correctness of the application before final submission. The applicants are also advised to keep the reference number allotted to them after final submission for future reference.

11. Applicants should send the print-out of the online application along with the supporting documents to this Department immediately.
12. Applicants are also advised to have a copy of the online generated application for their reference.
13. All communications with regard to this empanelment will be published in the official website "<http://schooledn.puducherry.gov.in>. Applicants are advised to access the above. They are advised to keep the mobile number given in the online application active for sending information, if any, connected with this empanelment.
14. The empanelment is purely provisional as it will be made based on the information furnished by the candidates in their online applications. The empanelled candidates should produce the required certificates such as educational qualifications, nativity/residence certificate, Community certificate, claiming relaxation/ concession under any other special category and Employment Exchange registration card etc. **in original** at the time of certificate verification, failing which their names will be deleted from the empanelled lists.
15. Empanelment of candidates is only provisional as they will be engaged only when necessity arises. Calling for certificate verification will also not confer any right on the candidate for claiming engagement.
16. No correspondence will be entertained with regard to the empanelment process.
17. The admission to the examination is only provisional. The decision of the Government as to the eligibility or otherwise of the applicant for admission to the Examination (for Guest Bala Sevika, Guest Computer Instructor and Guest Lecturer) shall be final.
18. Candidates are required to download the Hall Tickets for examination from the web-sites indicated. Candidates shall be intimated about the same through e-mail/press note.
