Bachelor of Physical Education (B.P.Ed) with at least 55% Marks, from a recognised University / Institution.</p> <p style="text-align: center;">OR</p> <p>Bachelor of Physical Education (BPE) with at least 55% Marks, from a recognised University/ Institution.</p> <p style="text-align: center;">OR</p> <p>Bachelor of Science (B.Sc.) in Health and Physical Education and Degree in Sports, with at least 55% Marks, from a recognised University / Institution.</p> <p style="text-align: center;">AND</p> <p>ii. M.P.Ed of at least 2 years duration from any National Council for Teacher Education Recognised Institution.</p> <p style="text-align: center;">AND</p> <p>iii. Should have studied the particular Regional language (Tamil/Telugu/Malayalam) as one of the subjects upto Secondary level.</p>
8.	Whether age and educational qualifications prescribed for direct recruits will apply in the case of promotees ?	:	<p>Age : No</p> <p>Educational qualification: As per Column No.11</p>
9.	Period of probation , if any	:	Two years for direct recruits

Working knowledge of the regional language. <p>NOTE-1: The need for Mandatory training before promotion should be considered by the Ministries /Department. Department shall facilitate the said training.</p> <p>NOTE-2: Where juniors who have completed their qualifying / eligibility service are being considered for promotion, their seniors would also be considered provided they are not short of the requisite qualifying / eligibility service by more than half of such qualifying / eligibility service or two years, whichever is less, and have successfully completed their probation period for promotion to the next higher grade along with their juniors who have already completed such qualifying / eligibility service.</p> <p>NOTE-3: Qualification required for promotees under Sl.No. (ii) is only applicable to the Physical Education Teachers those who had not studied the particular regional language i.e. Tamil / Malayalam / Telugu as one of the subjects in the Secondary level. The working knowledge of Regional language should be assessed by conducting a written test which is pre-requisite for promotion.</p>

(Education) - Member Director of School Education - Member
