Note-1: The crucial date for determining the age limit shall be the closing date for receipt of applications from candidates

Note-2: In the case of recruitment made through the Employment Exchange, the crucial date for determining the age limit shall, in each case, be the last date upto which the Employment Exchanges are asked to submit the names.

- 7. Educational and other qualifications : required for direct recruits
- (i) Masters Degree in Physical Education (Two Years duration) of a recognised University.
- Diploma in Coaching from SAI (Sports Authority of India) / NSNIS (Netaji Subhas National Institute of Sports) or from any other recognized Indian University.
- (iii) Should have studied the particular Regional Language (Tamil / Malayalam / Telugu) as one of the subject in the Secondary Level.

NOTE: Preference will be given to those candidates who have participated as Coach in International / National level, sports activities. The preference will be considered at the following order of merit:-

- a) Represented as Coach in an International Competition.
- b) Represented as Coach for State/U.T. in the Senior or Junior Level National Championships.
- c) Represented as Coach for University in an Inter University competition.
- d) Represented as Coach for the State Schools in the National Sports/ Games for Schools.
- 8. Whether age and educational : Not applicable. qualifications prescribed for direct recruits will apply in the case of promotees.
- 9. Period of probation, if any

- Method of recruitment, whether by direct : 10. recruitment or by promotion or by deputation / absorption and percentage of the vacancies to be filled by various methods
- 11. In case of recruitment by : promotion/deputation/absorption, grades from which Promotion / Deputation / absorption is to be made

Deputation (Including Short Term Contract):

'Officers of the Central Government, State Government. Union Territories, Autonomous or Statutory Organization, Public Sector Undertakings, University or Recognised Research Institution:

a) (i) Holding analogous posts on a regular basis in the parent cadre or department; or

(ii) with two years service rendered after appointment to the post on a regular basis in Level:7 in the Pay Matrix (Pre-revised Pay Band-II ₹.9300-34800 and Grade Pay ₹.4600) or equivalent in the parent cadre or Department; and

b) Possessing the educational qualifications prescribed for direct recruits under Column No. 7.'

(Period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or departments of the Central / State / Union Territory Government shall ordinarily not exceed three years. The maximum age limit for appointment by deputation shall be "not exceeding 56 years" on the closing date of receipt of applications)
