PROPOSED RECRUITMENT RULES FOR THE POST OF
TRAINED GRADUATE TEACHER

1. **Name of the Post** : Trained Graduate Teacher
 2. **Number of posts** : 2270 (Two thousand two hundred and seventy) (2018)

3. **Classification** : General Central Services - Group 'B', Non-Gazetted, Non-Ministerial
 4. **Level in the Pay Matrix** : Level : 7
 5. **Whether selection post or non-selection post** : Non-selection
 6. **Age Limit for direct recruits** : Not exceeding 30 years.
[Relaxable for Government Servant upto 5 years in accordance with orders or instructions issued by the Central Government].
- Note: The crucial date for determining the age limit shall be the closing date for receipt of applications from candidates in India (and not the closing date prescribed for those in Assam, Meghalaya, Arunachal Pradesh, Mizoram, Manipur, Nagaland, Tripura, Sikkim, Ladakh Division of Jammu and Kashmir State, Lahaul and Spiti Districts and Pangi Subdivision of Chamba District of Himachal Pradesh, Andaman and Nicobar Islands and Lakshadweep.)*
7. **Educational and other qualifications required for direct recruits** :
 - (1) Graduation with at least 50% marks and B.Ed. /Degree in Teaching / Education from a recognized University
or
Higher Secondary with 50% marks and 4-year B.A./B.Sc.Ed or B.A.Ed/B.Sc.Ed. from a recognized University;
AND
 - (2) Pass in Central Teacher Eligibility Test (CTET), Paper -II
AND
 - (3) Should have studied the particular Regional Language (Tamil/Telugu/Malayalam) as one of the subjects upto the Secondary level. In respect of Schools with medium of Instruction in French should have studied Brevet Elementaire de Francais. However, this qualification is not required for the Trained Graduate Teacher in the discipline of Tamil, Telugu, Malayalam and French as these languages are regional language of Union Territory of Puducherry.
- Note-1:**
Candidate should possess the Graduation in the respective subject / language, as detailed below:
- (i) **Mathematics** – Bachelor's Degree in Mathematics.
 - (ii) **Science** – Bachelor's Degree in Physics or Chemistry or Botany or Plant Science or Zoology.

(iii) **Social Science** – Bachelor's Degree in History or Geography or Political Science or Economics or Commerce or Historical Studies.

(iv) **English** - Bachelor's Degree in English or Functional English or English Language Literature.

(v) **French** - Bachelor's Degree in French Language.

(vi) **Tamil**- Bachelor's Degree in Tamil or Functional Tamil.

(vii) **Telugu**: Bachelor's Degree in Telugu or Special Telugu or Telugu Literature.

(viii) **Malayalam, Hindi, Sanskrit and Arabic** - Bachelor's Degree with main subject in the respective language.

Note- 2:

The qualifying marks in Teacher Eligibility Test for various categories of persons are in accordance with G.O.Ms. No.76 dt. 18-03-2015 of the Directorate of School Education (Secretariat Wing), Puducherry.

Note-3: Candidates who had already appeared for Tamil Nadu Teacher Eligibility Test (TNTET), Kerala Teacher Eligibility Test (KTET) and Andhra Pradesh Teacher Eligibility Test (APTET), prior to 18.03.2015 and secured the qualifying marks prescribed in G. O. Ms. No. 76 dated 18.03.2015 of the Directorate of School Education (Secretariat Wing), Puducherry will also be considered eligible till the validity period of the certificates, i.e., for seven years from the date of issue of certificate.

8. Whether age and educational qualifications prescribed for direct recruits will apply in the case of promotees :

Age : No

Educational qualification: Yes

NOTE: In respect of Educational qualification mentioned at Serial No.2 under Column No.7, a pass in Paper-II in Teacher Eligibility Test need not be required to the eligible Primary School Teachers who have already passed Teacher Eligibility Test in Paper-I.

9. Period of probation, if any :

Two years for direct recruits only.

10. Method of recruitment, whether by direct recruitment or by promotion or by deputation /absorption and percentage of the vacancies to be filled by various methods. :

20% by promotion failing which by direct recruitment.
20% by promotion through Limited Departmental Competitive Examination failing which by promotion.
60% by Direct Recruitment.

11. In case of recruitment by promotion/deputation/absorption, grades from which promotion/deputation /absorption is to be made :

Promotion:-

Primary School Teacher in Level :6 in the Pay Matrix, with five years regular service in the grade.

Limited Departmental Competitive Examination:-

Limited Departmental Competitive Examination for promotion is limited to Primary School Teacher in Level:6 in the Pay Matrix, with five years regular service in the grade.

Note-1: Only those who opted promotion to the post of Trained Graduate Teacher will be considered for promotion.

NOTE-2: The educational qualification shall continue to be same for the persons holding the feeder grade posts on regular basis on the date of notification of the Revised Rules.

Note-3: Where juniors who have completed their qualifying/eligibility service are being considered for promotion, their seniors would also be considered, provided they are not short of the requisite qualifying /eligibility service by more than half of such qualifying/eligibility service or two years whichever is less and have successfully completed their probation period for promotion to the next higher grade alongwith their juniors who have already completed such qualifying/eligibility service.

12. If a Departmental Promotion Committee exists, what is its composition? :


Group 'B' Departmental Promotion Committee (for considering Promotion):-

- a) Chief Secretary to Government - Chairman
- b) Secretary to Govt.(Education.) - Member
- c) Director of School Education - Member

Group 'B' Departmental Confirmation Committee (for considering confirmation) :-

- a) Chief Secretary to Government - Chairman
- b) Secretary to Govt.(Education.) - Member
- c) Director of School Education - Member

13. Circumstances in which Union Public Service Commission is to be consulted in making recruitment: :
- Consultation with Union Public Service Commission is not necessary.
