ORDER

Sub: DSE – Filling up of 10% of Pre-KG and LKG Seats in the Amrita Vidyalayam School, Moolakulam, Puducherry –during 2019-20- Guidelines – Issued.

Ref: Order No.3609/CHR/T1/243 dt. 28.02.2011 of the Department of Hindu Religious Institutions & Wakf, Puducherry.

In pursuance of the resolution of the Council of Ministers communicated by Order referred above, the Amrita Vidyalayam School, Moolakulam, Puducherry has requested the Govt. to sponsor students for admission to Pre-KG and LKG Class under Govt. quota.

2. Accordingly, the guidelines for filling up of 10% of Pre-KG and LKG Seats (09 students in each class) for the academic year 2019-20 in the Amrita Vidyalayam School, J.J.Nagar, Villupuram Main Road, Moolakulam, Puducherry, is detailed below for compliance:

1. Eligibility of the Children :-

The students who are residents of Union Territory of Puducherry, belonging to Below Poverty Line (BPL) families (annual income of parent or guardian is below Rs.75,000/- per annum) and completed 3 years of age as on 31.03.2019 (i.e. the child should have born on or before 31st March 2016 for LKG and 31.03.2017 for Pre-KG) shall be eligible to be admitted against the 10 percent of the seats (i.e. 18 students) in the Pre-KG and LKG class for the academic year 2019-20 reserved by the management of the school. However, the Tuition fees for the selected candidate should be paid by the parent or guardian only.

2. Selection of Students:-

- (i) The Committee constituted by the Directorate of School Education shall notify the number of seats reserved for the category of BPL section in the public domain or in the notice board, calling for applications from the eligible children.
- (ii) After receipt and scrutiny of the applications, the Committee shall prepare the list of all the eligible candidates to be selected and display it in the notice board and shall also intimate the date of selection.
- (iii) On the date of selection, the Committee shall select the children in the presence of the parents, by **Random Method (Lot system)**, for ensuring transparency.
- (iv) The select list shall be displayed in the notice board along with the waiting list. The parents/guardians should admit their children within Five days from the date of selection failing which, the selection will be cancelled and the seats will be allotted to other children in the waiting list.
- (v) No other method of selection other than random method shall be applied for selecting the students.

NOTE : The filled-in application should reach the Office of the Joint Director (School Education), Puducherry, on or before 12.04.2019 (Friday).
