ORDER:

The following amendment shall be substituted in the Annexure to the G.O. in para 7 under sub para V under the sub head of Higher Secondary Level, in the G.O. (1) read above:

Sl. No.	Name of the post	Existing norms	Amendment proposed
1.	Principal	One post of principal for every higher secondary school. The Principal has to handle not less than 6 periods per week for higher standards, in addition to administration and academic supervision.	One post of principal for every higher secondary school. The Principal has to handle one complete subject for a class based on his subject, not less than 6 periods per week for higher secondary standards, in addition to administration and academic supervision
2.	Vice Principal	One post of Vice- Principal for every higher secondary school. The Vice-Principal has to handle not less than 12 periods per week for higher secondary standards, in addition to assisting the Principal in the administrative and academic matters.	One post of Vice-Principal for every higher secondary school. The Vice- Principal has to handle one complete subject for a class, based on his subject, not less than 12 periods per week for higher secondary standards, in addition to assisting the Principal in the administrative and academic matters
3.	Lecturer and Instructor	Requirement of post is worked out based on subject requirement. The Lecturers/Instructors are required to handle not less than 24 periods per week and if any teacher has lesser than the above said work load, his services shall be utilised to other needy schools.	Requirement of post is worked out based on subject requirement. The Lecturers/Instructors are required to handle not less than 24 periods per week. If any Instructor has lesser than 24 periods per week, his services shall be utilised to other needy schools. The Lecturer who has not handled 24 periods per week at higher secondary level shall handle classes of IX & X at high school level to compensate the shortage of 24 periods.

2. The other terms and conditions remain unaltered.
