The management of ‘Sri Samboorna Vidya Bhavan Primary School’, Poornankuppam & Post, Edaiyarpalayam, Puducherry is hereby directed to **CLOSE DOWN** the school during this academic year 2018-19, due to lack of adequate infrastructure facilities, poor student strength, lack of basic amenities and conducting of derecognized Middle school level classes, non-compliance of the instructions issued vide recognition order cited under ref.(i) above and based on the recommendations of the Inspecting Officer concerned cited under ref.(iii) above. Further, it is observed that the management of the said school has not fulfilled the norms stipulated in the Puducherry School Education Act (PSEA), 1987 Puducherry School Education Rules (PSER), 1996 and the Puducherry Right of Children to Free and Compulsory Education Rules (RTE), 2011.

Hence, the management is hereby instructed to immediately issue Transfer Certificates to the students of all the existing classes, countersigned by the Inspecting Officer concerned and not to conduct the said school in the ensuing academic years also, without obtaining prior permission from the Directorate of School Education, Puducherry. Further, it is also instructed to hand over all the records and registers pertaining to the school to the Inspecting Officer concerned, for further future reference as required under Rule 30 (2) of the Pondicherry School Education Rules, 1996,
