OFFICE MEMORANDUM

Sub: DSE – Estt.III – Absorption of Block Resource Teachers / Cluster Resource Centre Co-ordinators and Trained Graduate Teachers on contract basis engaged in Samagra Shiksha UT Mission Authority, Puducherry as Trained Graduate Teachers – Offer of appointment – Orders – Issued.

Ref: G.O. Ms. No.35, dated 31.01.2022 of Directorate of School Education (Secretariat Wing), Puducherry.

In pursuance of the G.O. cited, the Block Resource Teachers / Cluster Resource Centre Co-ordinators and Trained Graduate Teachers on contract basis engaged in Samagra Shiksha UT Mission Authority, Puducherry mentioned in the annexure to this order are offered the post of **Trained Graduate Teacher** on purely temporary basis and posted in the institutions noted against each. They will draw pay in **Level 7 of Pay Matrix as per 7th CPC**. They are also entitled to draw the dearness and other allowances at the rates as admissible and subject to the conditions laid down in rules and orders governing the grant of such allowances in force from time to time.

2. The terms of appointment are as follows:-

- i) The appointment is purely temporary and on regular basis;
- ii) Other conditions of service will be governed by the relevant rules and orders in force from time to time;
- iii) They are liable for transfer to any Institution / School in the Union Territory of Puducherry and should undertake to serve in the Institution / School, where posted;

3. The appointment will be further subject to:-

- i) Production of Certificate of fitness from the Competent Medical Authority (R.M.O.);
- ii) Submission of declaration in the form enclosed and in the event of individual having more than one spouse living or being married to a person having more than one spouse living, the appointment will be subject to her being exempted from the enforcement of the requirement in this behalf;
- iii) Submission of attestation forms for verification of character and antecedents along with joining report. The attestation forms may be obtained from the concerned Head of Office;

- iv) Submission of declaration to the effect whether the individual is serving or is under obligation to serve in another Central Government Department / State Government or Public Authority.
4. The Certificates / declarations should be produced to the concerned Head of Office at the time of reporting for duty.
5. If any declaration given or information furnished by the individual proves to be false or if the individual is found to have wilfully suppressed any material information, he/she will be liable to be removed from service and such other actions as the Government may deem necessary.
6. The appointee is further informed that he/she should serve in the Institution / School posted for a minimum period of three years from the date of appointment and canvassing in any form for transfer will lead to cancellation of this offer of appointment.
7. If he/she accepts the offer on the above terms, he/she should report for duty before **the Head of Office concerned on or before 28.02.2022**. If no reply is received or if the individual fails to report for duty by the prescribed date, the offer of appointment will be treated as cancelled. No travelling allowance will be allowed for joining the post. If any extension of time for joining is required he/she should apply directly to the Director of School Education, Puducherry.


