TENDER-CUM-PUBLIC AUCTION NOTICE

Sealed tenders are invited for offering highest rate per lot for sale of unserviceable/damaged, obsolete furniture items of each school under the control of the Office of the Chief Educational Officer, Puducherry, in "as-is-where-is condition".

2. The details of the schools and its unserviceable/damaged, obsolete furniture items are furnished in the Annexure-I.

3. The tenders in sealed covers should be addressed to the Chief Educational Officer, Puducherry duly sealed and superscribed on the envelope as "Tender for purchase of unserviceable / damaged, obsolete furniture items" and to reach the undersigned on 14.06.2022 between 02.50 p.m to 3.00 p.m. The received tenders will be opened on the same day at 3.30 pm in the presence of the tenderers or their authorised representatives who are present at the time of opening of tender. If, the tenders opening day happens to be a public holiday, the same will be opened on the next working day.

4. Tenders received after the due date and time will summarily be rejected. The tenderer who have submitted tender in sealed cover only allowed to participate in the public auction.

5. The intending tenderer should deposit an amount of Rs.5000 (Rupees five thousand only) as earnest money deposit. The earnest money deposit of unsuccessful tenderers will be returned immediately after the tender/auction sale is over.

6. The tenderer can inspect the unserviceable / damaged, obsolete furniture items available in schools during the office hours with the permission of the Headmaster/Headmistress from 09.06.2022 to 10.06.2022.

7. If, the highest tender amount offered by the tenderer is found to be not acceptable, the public auction will be conducted on the spot, keeping the highest tender amount as minimum bid amount.

8. No claim about the quantity, quality and value of the materials will be admitted once the tender/auction is finalised. This Office is not responsible for the safe custody of the articles once the tender/auction is over.


9. The tenderers should submit the following self-attested copies of the documents along with their tender. i.e (i) Valid GST certificate (ii) PAN Card (iii) Aadhaar Card.

10. The successful tenderer/bidder should pay the entire amount immediately and clear all articles within 24 hours at his /her own risk and cost, failing which the earnest money deposit will be forfeited, GST rate in force will be charged extra on the amount finalised.

11. The undersigned reserves the right either to accept or reject any tender or all without assigning any reason thereof. The decision of the undersigned is final in case of any dispute.
