The undersigned hereby offers appointment on absorption basis to **Thiru. Ginish Gopinath, Part Time Bal Bhavan Instructor (Creative Art), Mahe as Bal Bhavan Instructor(Creative Art) (Group C)** in the Level – 2 of the Pay Matrix which is mentioned below with immediate effect against the posts created in G.O.Ms.No.78 dt.07.07.2006.

The appointee is also entitled to draw the dearness and other allowances at the rates as admissible and subject to the conditions laid down in rules and orders governing the grant of such allowances in force from time to time.

2. The approval of the Lt. Governor has been obtained for the relaxation of age and educational qualifications vide G.O. Ms. No.17 dated 04.07.2023 of the Under Secretary to Govt. (School Edn.), Puducherry.

3. The terms of appointment are as follows: -

- i. The appointment is purely temporary and on regular basis and may be terminated by a month's notice given by either side viz. the appointee or the Appointing Authority at any time without assigning any reason.
- ii. Other conditions of service will be governed by the relevant rules and orders in force from time to time.
- iii. The candidate is liable for transfer to any institution/school in the Union territory of Puducherry and should undertake to serve in the institution/school where posted.
- iv. The candidate shall discharge his regular duty as Bal Bhavan Instructor in the J.B.B./J.M.B.B. posted from 4.30 p.m. to 6.30 p.m. on all days except Sunday and public holidays and he shall handle classes or do other works assigned to him by the Head of the school concerned for the forenoon session on all school days since his services have been spared to the Govt. Primary School.
- v. He is entitled to leave as admissible to non-vacation staff, since his services are required in the vacation period of the school.

4. The appointment will be further subject to:

- i. Production of certificate of fitness from the Competent Medical Authority (R.M.O).
- ii. Submission of a declaration in the form enclosed (Annexure-I) and in the event of the candidate having more than one wife living or being married to a person, having more than one wife living, the appointment will be subject to him being exempted from the enforcement of the requirement in this behalf.
- iii. Submission of attestation forms for verification of character and antecedents along with joining report. The attestation forms may be obtained from the Head of Office concerned.
- iv. Submission of declaration to the effect whether the candidate is serving or is under obligation to serve another Central Government Department/State Government or Public Authority.

5. The original certificates / declarations should be produced to the Deputy Director (Elementary Education), DSE, Puducherry at the time of reporting for duty.
6. In case it is found that he was guilty of misconduct involving moral turpitude, which would disqualify him for Government Service, or had suppressed any material fact relating to his conduct prior to entry into Government Service or if any declaration given or information furnished by the candidate proves to be false, he will be liable to be discharged from service and such other action as Government may deem necessary.
7. If the candidate accepts the offer on the above terms and conditions, he should report for duty before the Deputy Director (Elementary Education), DSE, Puducherry **on or before 19.09.2023**. If the candidate fails to report for duty within the prescribed date, the offer of appointment will be treated as cancelled, and no further communication will be entertained.
8. The candidate is informed that no traveling allowance will be allowed for joining the post.
