ABSTRACT**

School Education (Secretariat Wing) – Setting up of a separate Directorate for Sports and Youth Affairs in the Union Territory of Puducherry by way of carving out the subjects from the Directorate of School Education, Government of Puducherry – Orders issued.

ORDER:

The Government of Puducherry, considering the long pending genuine demand of the sports fraternities and stakeholders decided it necessary to have a separate Directorate, bifurcating the subjects of Sports and Youth Affairs from the Directorate of School Education, Puducherry. With a view to exclusively facilitate the planning, implementation and monitoring of various Schemes relating to Sports Sector and Youth Affairs Sector, thereby ensuring the sustainable growth and development of Sports and other Youth related activities in the UT of Puducherry, the Government is pleased to bifurcate the Directorate of School Education, viz., "Directorate of Sports and Youth Affairs" with effect from the date of issue of this Order.

2. The Institutions & Schemes hitherto controlled and implemented by the Directorate of School Education as in Annexure-I shall be brought under the newly created Directorate of Sports & Youth Affairs. Further, the Infrastructure hitherto under the maintenance of Directorate of School Education as in Annexure-II shall stand transferred to the newly created Directorate of Sports and Youth Affairs, Puducherry for future maintenance.

3. For the newly created Directorate of Sports and Youth Affairs, Puducherry, one Pondicherry Civil Services Officer will be the Head of the Department; the salary and other allowances in respect of the Director of the newly created Director of Sports and Youth Affairs shall be claimed against the post of Deputy Director of Sports. Until the post is filled-up, the Director of School Education will hold the additional charge of the post of Director of Sports & Youth Affairs. The posts as detailed in Annexure-III to this G.O., stands transferred to the newly created department. The various Sports and Youth Affairs related Schemes/Activities etc., hitherto implemented through the Directorate of School Education, Puducherry shall hereafter be implemented through the Directorate of Sports and Youth Affairs, Puducherry. The files/proposals submitted by the NCC Group Head Quarters, Puducherry to the Directorate of School Education, Puducherry shall henceforth be submitted to the newly created Directorate of Sports & Youth Affairs, Puducherry.

4. The Head of the Department as mentioned in para 3 above shall be the Head of Department under S.R.2 (10) for the purpose of Fundamental Rules, Supplementary Rules and CCS (Leave) Rules, 1972 and shall also be the controlling officer under S.R.191 for the purpose of travelling allowances and medical reimbursement claims in respect of all the Group 'A' and 'B' Officers under his/her control. The Secretary to Government (Education), will be the controlling officer for the purpose of travelling allowance and medical reimbursement in respect of the Head of the Department.

5. The Director of School Education, Puducherry shall facilitate allocating sufficient space for setting up the Directorate of Sports and Youth Affairs, Puducherry within the premises of the Perunthalaivar Kamarajar Education Complex, Anna Nagar, Nellithope, 100 Feet Road, Puducherry. The existing Secretariat Wing (School Education), Puducherry under the Secretary to Government (Education), Puducherry will be the Administrative Secretariat for the newly created Directorate of Sports and Youth Affairs, Puducherry.

6. Till such time regular arrangements are made, the Deputy Collector (Revenue) Karaikal and Regional Administrators, Mahe and Yanam are hereby declared to be the Head of Office for the respective regions under rule 14 of the Delegation of Financial Powers Rules, 1978 in respect of the schemes/activities enumerated in para 2 above and are also declared to be the controlling officers under S.R.191 for the purpose of travelling allowance and medical reimbursement claims and also for sanctioning all kind of leave in respect of Group 'C' and 'D' Staff of the Directorate of Sports and Youth Affairs.
7. The Head of Department shall be the disciplinary authority and appointing authority for Group 'C' and 'D' staff of the Directorate of Sports and Youth Affairs.
8. The Head of the Department and Head of the Offices shall perform the regular duties and responsibilities attached to their posts.
9. The Budget allocations under the Major Head 2204 – Sports and Youth Services of Revenue Section and under the Head "4202 – Capital Outlay on Education Sports Art and Culture – 03 – Sports and Youth Services of Capital Section pertaining to the Sports & Youth Services/Affairs, prevailing under Demand 10 and other subjects allotted to the Directorate of Sports & Youth Affairs shall be duly utilized by the newly created Directorate depending upon the allocated subjects, schemes, etc.
10. All other existing arrangements such as arrangement for drawing and disbursing authorities, etc., will remain unaltered, unless otherwise necessity arises and further orders issued.
