The validity period of Internal Complaints Committees (ICCs) constituted vide order first cited under the Sexual Harassment of Women at Work Place (Prevention, Prohibition & Redressal) Act, 2013, in the Offices of the Inspecting Officers of this Directorate expired on completion of three years. Consequently, ICCs were reconstituted for the Offices of the JD/CEO/DD(W), Puducherry, upon their request, vide reference third cited.

2. Now, internal Complaints Committees are reconstituted for the remaining sub offices as detailed in the annexure, with the members as proposed by the Inspecting Officers and as per the modification request of the CEO, Puducherry. The Internal Complaints Committee so reconstituted will act upon the complaints and enquire the complaints as per the terms and guidelines in the annexure-III of the circular second cited.

Further, it is directed that this order for reconstitution of Internal Complaints Committee and the guidelines of the Circular cited above, shall be displayed in the notice board of all the Government Schools/Establishments under the control of each of the Inspecting Officers of DSE, Puducherry.
