It is informed that the Government of Puducherry is granting full fees to the eligible students of Scheduled Caste and Scheduled Tribe studying in the recognized private schools, colleges and universities in the U.T. of Puducherry under the scheme "Grant of full fees to the eligible scheduled caste and scheduled tribe students irrespective of income ceiling to pursue their studies in any private school recognised by Government including Government aided schools and to pursue higher / professional courses in colleges and universities in the Union Territory of Puducherry" and the Department of Adi Dravidar Welfare and Scheduled Tribes Welfare is implementing this scheme from the year 2020-21 as per the rules / guidelines notified in the order cited at reference.

Now, the Director, Department of Adi Dravidar Welfare and Scheduled Tribes Welfare in the letter cited at reference has requested this Directorate to convene a meeting of all the Government aided and Government recognised private schools to find out the amicable solution for the issues / incidents faced by the SC / ST students, their parents and institutions in the implementation of this scheme.
