CIRCULAR

Sub: DSE-Dte. Estt- Filling up of vacant posts of Head Master Grade II by promotion from eligible TGT-Service Particulars and other documents –Called for – Reg.

It is proposed to fill up the vacancies in the cadre of Headmaster Gr.II by promotion on regular basis in Puducherry, Karaikal, Mahe and Yanam from eligible feeder cadre Trained Graduate Teachers (subjects and Languages) of this Directorate.

- 2. As per Recruitment Rules of the post of Headmaster Gr.II promotion is to be made from the combined seniority list in the cadres of Trained Graduate Teachers in subjects and Languages with four years experience in the respective grades and possessing the educational qualification prescribed for the post i.e. B.A.,/B.Sc.,/B.Com or equivalent degree with a degree in Teaching of a recognized University or C.A.P.
- 3. The Heads of Offices/Institutions are requested to furnish the service particulars of the eligible officials from the grade of Trained Graduate Teachers (subjects and Languages) who were appointed till 2007 for being considered for promotion to the post of Headmaster Gr.II in the prescribed proforma enclosed.
- 4. In the case of the teachers claiming reservation under SC category, they should produce certificate which is recognized as Scheduled caste under "The Constitution of India (Pondicherry) Scheduled Caste order 1964", dated 05.03.1964 read with "The constitution of India(Scheduled Caste) orders(Second Amendment Act, 2022(Central Act 61 of 2002) and produce certificate therefor issued on or after 06.10.2023 by an officer of the Department of Revenue and Disaster Management not below the rank of Deputy Tahsildar without fail.
- 5. The following certificates/documents should be furnished along with the service particulars.
 - i) Option form
 - ii) Integrity Certificate.
 - iii) Certificate to the effect that no Disciplinary proceedings is pending/being contemplated against the official
 - iv) Certificate to the effect that the official has no break in service.
 - v) Self attested copies of certificates of Bachelor's Degree and B.Ed., or B.T Degree.
- 6. **The APARs of the officials need not be sent** along with the service particulars and the same will be called for later separately.
- 7. The details of TGTs who have been promoted as Lecturer/ reverted back to TGT on their own request/ declined promotion in the last DPC shall be furnished in the remarks.

- 8. The services particulars along with the certificates/documents of all the eligible teachers should reach this Directorate on or before 10.11.2023 without fail. Belated Submission will not be entertained. Personal attention of the Heads of Institutions/ Inspecting Officers is required to ensure that no eligible official has been left out for consideration and that the service particulars of eligible teachers furnished are correct. A Certificate to the effect is also required to be furnished. In case, there are no eligible teachers for being considered, a NIL report may invariably be furnished within the prescribed date.
- 9. It is requested that the particulars of eligible teachers working in the schools under their control may be collected and furnished in a consolidated manner.
- 10. It may be noted that omission of eligible teachers or furnishing of incorrect particulars, if any will be viewed seriously and responsibility will be fixed on the concerned Heads of Institutions/Inspecting Officers.
 - 11. This issues with the approval of the Director of School Education.
