CIRCULAR

Sub: DSE-Dte. Estt- Filling up of vacant posts of Head Master Grade I by promotion from eligible Headmaster Gr.II on adhoc basis-Service Particulars and other documents –Called for – Reg.

It is proposed to fill up the vacancies in the cadre of Headmaster Gr.I by promotion on adhoc basis in Puducherry, Karaikal, Mahe and Yanam from eligible feeder cadre Headmaster Gr. II of this Directorate.

2. As per existing Recruitment Rules for the post of Headmaster Gr.I, promotion is to be made from the Headmaster Grade-II with ten years teaching experience including with three years service experience in the respective grades and possessing the educational qualification prescribed for the post i.e. B.A.,/B.Sc.,/B.Com or equivalent degree with a degree In Teaching of a recognized University or C.A.P.

3. The Heads of Offices/Institutions are requested to furnish the service particulars of the eligible officials from the grade of Headmaster Gr.II for being considered for promotion to the post of Headmaster Gr.I in the prescribed proforma enclosed.

4. In the case of the teachers claiming reservation under SC category, they should produce certificate which is recognized as Scheduled caste under "The Constitution of India (Pondicherry) Scheduled Caste order 1964", dated 05.03.1964 read with "The constitution of India(Scheduled Caste) orders(Second Amendment Act, 2022(Central Act 61 of 2002) and produce certificate therefor issued on or after 06.10.2023 by an officer of the Department of Revenue and Disaster Management not below the rank of Deputy Tahsildar without fail.

5. The following certificates/documents should be furnished along with the service particulars.

i) Integrity Certificate.

ii) Certificate to the effect that no Disciplinary proceedings is pending/being contemplated against the official

iii) Certificate to the effect that the official has no break In service.

iv) Self attested copies of certificates of Bachelor's Degree and B.Ed., or B.T Degree.

6. The APARs of the officials need not be sent along with the service particulars and the same will be called for later separately.

7. The services particulars along with the certificates/documents of all the eligible teachers should reach this Directorate on or before 05.11.2024 without fail. Belated Submission will not be entertained. Personal attention of the Heads of Institutions/ Inspecting Officers is required to ensure that no eligible official has been left out for consideration and that the service particulars of eligible teachers furnished are correct. A Certificate to the effect is also required to be furnished. In case, there are no eligible teachers for being considered, a **NIL report** may invariably be furnished within the prescribed date.

8. It is requested that the particulars of eligible teachers working in the schools under their control may be collected and furnished in a consolidated manner.

9. It may be noted that omission of eligible teachers or furnishing of incorrect particulars, if any will be viewed seriously and responsibility will be fixed on the concerned Heads of Institutions/Inspecting Officers.

10. This promotion on adhoc basis shall be subject to the outcome of Review Petition Sr. No:47507 of 2018 of the Hon'ble High Court of Judicature of Madras.

11. This issues with the approval of the Director of School Education.
