4. They should report for duty before the Head of Institution /Controlling Authority concerned on or before 03.01.2025, failing which it will be presumed that he has declined the offer and he will not be considered for promotion for a period of one year or next DPC, whichever is later.

5. No leave should be granted at the time of relief. No request for retention or transfers to any other school will be entertained at any cost. The officials should be relieved without waiting for substitute. The Head of Institution/Controlling Authority is requested to relieve the promoted within the stipulated date and submit a compliance report on or before 08.01.2025.
