As per Recruitment Rules for the post of Principal, the post is filled by promotion in the ratio of 2: 3 from the grade of **regular Vice Principal/Headmaster Grade-I** possessing Post Graduate Degree from a recognized University or equivalent and Degree in Teaching of a recognized University or equivalent with 6 years regular service in the grade.
- 3. The Heads of Offices/Institutions are requested to furnish the service particulars of the eligible officials except those who have retired, from this Directorate in the prescribed proforma enclosed.

Belated Submission will not be entertained. Personal attention of the Heads of Institutions/ Inspecting Officers is required to ensure that no eligible official has been left out for consideration and that the service particulars of eligible teachers furnished are correct. A Certificate to the effect is also required to be furnished. In case, there are no eligible teachers for being considered, a NIL report may invariably be furnished within the prescribed date.
