Sub: DSE – Estt-III – Promotion to the post of Lecturer (Physical Education) from Physical Education Teachers on regular basis – Orders - Issued.



2. The post shall carry pay in Level 8 of Pay Matrix plus other allowances as per the Revised Pay Rules under the rules in force from time to time.
3. The officials mentioned above are entitled for Transfer TA/ D.A and joining time.
4. He/She should report for duty before the Head of Institution /Controlling Authority concerned on or before 18.09.2024, failing which it will be presumed that he/she has declined the offer and he/she will not be considered for promotion for a period of one year or next DPC, whichever is later.
5. No leave should be granted at the time of relief. No request for retention or transfer to any other school will be entertained at any cost. The officials should be relieved without waiting for substitute. The Head of Institution/Controlling Authority is requested to relieve the promotees within the stipulated date and submit a compliance report on or before 23.09.2024.
6. No representation on whatsoever ground seeking extension of time beyond the prescribed joining time and/or change of place of posting will be entertained
