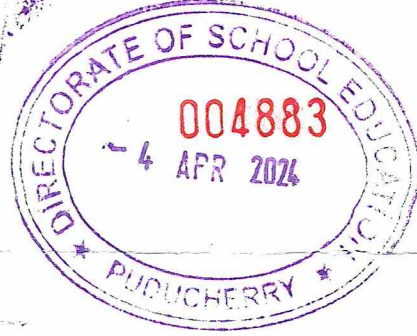

I am to inform that this Department is implementing a scholarship scheme of "Grant of Full Fees to the eligible SC/ST students irrespective of income ceiling to pursue studies in private schools recognized by Government including Govt. Aided Schools and to pursue Higher / professional courses in Colleges and Universities in the UT of Puducherry" from the year 2020-2021. Vide G.O. ms.no. 8/Wel(SCW)/2020-21/3808 dt.04.01.2021 in order to minimize the financial burden of the SC/ST students.
