DSE(Secretariat Wing) – Taking over of PONCOS Higher Secondary School, Lingareddipalayam, Puducherry (functioning under the aegis of Pondicherry Co-Operative Sugar Mills Limited, Puducherry by availing Grant-in-Aid from the Government of Puducherry) – Orders - Issued.

ORDER:

The Council of Ministers during their meeting held on 10.01.2025 approved the proposal to take over the Higher Secondary School presently functioning under the management of Pondicherry Sugar Mills Limited, Lingareddipalayam, Puducherry (PONCOS Higher Secondary School under Grant-in-aid Scheme) on as-is-where-is basis, including land, infrastructure and manpower with the expenditure borne directly by the Directorate of School Education, Puducherry through budgetary support prospectively vide Minutes of the Meeting read (2) above, communicated by the Secretariat of the Council of Ministers.

2. Accordingly, approval of the Lieutenant-Governor, Puducherry is hereby conveyed for taking over of the Higher Secondary School presently functioning under the management of Pondicherry Sugar Mills Limited, Lingareddipalayam, Puducherry (PONCOS Higher Secondary School under Grant-in-aid Scheme) on as-is-where-is basis, including land, infrastructure and manpower by the Director of School Education invoking provisions of Rule 23 of the Pondicherry School Education Rules, 1996, with the expenditure borne directly by the Directorate of School Education, Puducherry prospectively from the date of issuance of this Order with pending payments of dues by the Pondicherry Co-operative Sugar Mills Limited, Lingareddipalayam, Puducherry/Registrar of Co-Operative Societies, Puducherry.

3. The details of staff of PONCOS Higher Secondary School listed in **Annexure-I**, under Grant-in-Aid Scheme of the Government of Puducherry shall be taken into Government service by relaxing age, educational qualification etc. wherever necessary, by absorption. The seniority of the absorbed staff to be placed at the junior most level, below the existing officials in the respective cadre and their pay shall be fixed at the minimum of pay scale.
4. The details of staff listed in **Annexure-II**, not covered under Grant-in-Aid Scheme will be continued on contract basis in the Institution. The remuneration in respect of such Teaching Staff on contract basis would be governed as per G.O.Ms.No.46, dated 27.11.2023 of the Directorate of School Education (Secretariat Wing), Puducherry and the remuneration of such non-Teaching Staff/Common Category Staff on contract basis would be governed as per Orders of the Finance Department, Government of Puducherry being issued from time to time.
5. The Director of School Education, Puducherry, through the Inspecting Officer concerned, shall facilitate the taking over of the Furniture and Fixtures, Lab equipment, Books and forms etc., (pertaining to the PONCOS Higher Secondary School, Lingareddipalayam) by the Directorate of School Education, Puducherry on 'as-is-where-is condition' free of cost adopting due codal procedures. The Drawing and Disbursing Officer of the Institution shall ensure proper transition of cash balance if any, into the Government Account immediately on the issuance of this Order.
6. The Lieutenant Governor is pleased to further Order that the Directorate of School Education in co-ordination with the Mannadipet Commune Panchayat Council and the Registrar of Co-Operative Societies shall take necessary expeditious action to sever and make free the piece of land measuring 1,40,364.20 Square-meter of land on which the PONCOS Higher Secondary School is functioning, from the Lease hold Agreement entered into between the Mannadipet Commune Panchayat Council and the

Pondicherry Co-Operative Sugar Mills Ltd., Lingareddipalayam and to transfer it to the Education Department free of cost on 'No-Profit No-Loss' basis invoking provisions of Rule 309 and 310 of the General Financial Rules 2017; till such time the land is transferred to Education Department, the School shall function as usual - intact, in the existing premises.

7. This issues with the approval and concurrence of the Finance Department, vide I.D.No.38525/FD/F4/A4/2025-26, dated 14.07.2025.
