As per the instructions contained in O.M. No: 5/1/2008/CS-I(S) dated 08-04-2011 of DoPT, New Delhi that when a Government employee does not want to accept a promotion which is offered to him he may make a written request that he may not be promoted and the request will be considered by the appointing authority, taking relevant aspects into consideration. If the reasons adduced for refusal of promotion are acceptable to the appointing authority, the next person in the select list may be promoted. However, since it may not administratively be possible or desirable to offer appointment to the persons who initially refused promotion, on every occasion on which a vacancy arises, during the period of validity of the panel, no fresh offer of appointment on promotion shall be made in such cases for a period of one year from the date of refusal of first promotion or till a next vacancy arises whichever is later.

In view of the above instructions, the controlling officers/Head of offices are therefore requested to make necessary entries in the service book of the individuals about their non-acceptance of promotion and to monitor the debarment period of one year from the date of refusal of promotion, before sending proposal for promotion/financial upgradation under MACP scheme in future.
