Sub: DSE –iGOT Karmayogi Online Platform- Registration
and Participation of Group A, B and C Officers in online
courses - Reg.

As a part of initiative to enhance the skills and capabilities of all Government employees and to address the capacity building issues of the Civil Services it has been decided to mandate online training to Group A, B and C Officers/Officials of this Administration.

2. The DoPT has designed an iGOT Karmayogi online platform with wide range of courses to provide a comprehensive training to Government employees across various sectors.

3. In light of the above, all Government Officers/Officials were instructed to download iGOT App with this link <https://onelink.to/igotkb> and to register in the iGOT Karmayogi online platform with their existing official email ID or by e-registration with the official email ID given by NIC and undergo the online training as detailed below:

Group A – 3 or 4 Short Term Courses to be completed (including newly enacted three Criminal Laws)

Group B – 4 Short Term Courses to be completed(including newly enacted three Criminal Laws)

Group C – 3 Short Term Courses to be completed(including newly enacted three Criminal Laws)

4. However, the progress of enrolment of officials in IGot Karmayogi online portal was reviewed by the Secretary to Govt. (AR Wing) and noticed that there was a

lukewarm response to achieve the 100% enrollment/registration of the officials in the iGot platform.

5. The Heads of Offices and Inspecting Officers are therefore requested to bring the content of the circular/I.D.Note among the Officials including Teachers/ IOs to facilitate the participation of Officers/Officials in the iGOT Karmayogi platform to their sub ordinate officers in all the levels with instructions to actively participate in the training courses relevant to them and furnish compiled compliance report with the details of officers and the courses completed in the iGOT Karmayogi platform in the format as per the annexure along with the certificate through the following email address:dda-edn@py.gov.in, on or before 08.08.2025.
