TENDER-cum-AUCTION NOTICE

Sealed tenders are invited for disposal of old unserviceable / obsolete condemned articles such as wooden and steel furniture's and miscellaneous items belonging to this Institution, in "**as-is-where-is**" condition.

2. The tenders in sealed cover should be addressed to "The Headmaster, Calve College Govt. French High School, Mission St, Puducherry – 605 001", duly superscribed on the envelopes "**Tender for disposing old unserviceable obsolete items**" and shall reach the Undersigned **on or 26/02/2026 by 10.00am**. The received tenders will be opened on **the same day at 11.30pm** in the presence of tenderers or their authorised representatives who are present at that time. If the scheduled date of tender / auction happen to be a public holiday, the date of opening of tenders will automatically be postponed to the next working day at the same time.
 3. The tenderer should offer rate for "**the entire items as one lot**" in his tender. Public auction will be started from the highest rate quoted by the tenderers. The sale will be effected only to the highest bidder.
 4. The tenderers should deposit an amount of Rs. 4000/- (Rupees four thousand only) as Earnest Money Deposit (EMD) in cash. The EMD of the unsuccessful tenderers will be refunded immediately after the tender/auction sale is completed, whereas the EMD of successful tenderer will be returned only after the official process is completed in all aspects.
 5. The following self-attested photocopy of documents / certificates must be enclosed along with the tenders, viz.
 - i) Valid GST Certificate
 - ii) PAN card and
 - iii) Aadhar Card / Valid Family Ration Card / Valid Driving License.
- The tenders without the above-mentioned certificate / documents will be rejected.
6. Tenders received after the due date and time will not be entertained.2/-
