DRAFT RECRUITMENT RULES FOR THE POST OF FINE ARTS TEACHER

1.	Name of the post	: FINE ARTS TEACHER
2.	Number of posts	: 128 (2026*) subject to variation dependent on Work-load.
3.	Classification	: General Central Service-Group'B'-Non-Gazetted Non-Ministerial.
4.	Level in the Pay Matrix	: Level 6
5.	Whether selection post or non-Selection post	: Not applicable
6.	Age limit for direct recruits	: Between 18 and 30 years Relaxable for Government Servants up to five years in accordance with orders and instructions issued by the Central Government. Note: The Crucial date for determining the age limit shall be as advertised by the Competent Authority.
7.	Educational and other qualifications required for direct recruits	: i) Bachelor's degree in Fine Arts or its equivalent from a recognized University; ii) Technical Teachers Certificate awarded by Department of Technical Education, Government of Tamil Nadu or its equivalent and iii) Should have studied the particular regional language(Tamil/Telugu/Malayalam) as one of the subjects in the Secondary level/ Bachelor's Degree. NOTE: In respect of French Schools, if sufficient candidates with Brevet Élémentaire de Français are not available, and the candidate's mother tongue is Tamil, Telugu or Malayalam but has not studied Brevet Élémentaire de Français, a proficiency test shall be conducted to assess the candidate's knowledge and proficiency in French.
8.	Whether age and educational qualification for direct recruits will apply in the case of promotees	: Not applicable
9.	Period of probation, if any	: Two years
10.	Method of recruitment, whether by direct recruitment or by promotion or by transfer / deputation and percentage of the posts to be filled up by various methods	: 100% by Direct Recruitment Note: Selection will be made from the persons possessing knowledge of the regional language of Tamil, Malayalam or Telugu, as the case may be, according to the availability of vacancies in different regions of Union Territory of Puducherry at the time of selection.
