ORDER:

Sanction of the Lieutenant Governor is hereby accorded for the continued engagement of two Primary School Teachers in Ecole Centrale et Cours Complementaires, Mahe, to teach French subjects on consolidated pay basis of Rs.26,000/- per month per teacher for a further period of 6 months from 01.03.2026 to 31.08.2026 or till the regular vacancies are filled up whichever is earlier, as detailed below:-

The above said engagement on consolidated pay basis is being offered and may be voluntarily accepted as a limited time period and temporary assignment only, specific to the period mentioned above, without it being construed, in any manner or form, to be a long-term arrangement and will not confer upon the individual Primary School Teachers, so contractually re-engaged, any special

privileges or be the basis of any claims for preferential treatment at the time of regular filling up of the posts, beyond what is permissible and prescribed under the notified Recruitment Rules for the said post.
