Hence, outside participants are requested to attach Aadhar Card and Bank Mandate Form with the TA claim.

With the out region participants a Contingent Leader may accompany with the participants. Since, it is raining at Puducherry precautions may be done. All the participants should wear Face Mask and Standard Operating Procedure (SOP) of COVID-19 and precautions to be ensured.
