On the basis of the recommendations of the Departmental Promotion Committee, the Trained Graduate Teachers mentioned in the Annexure are promoted as Lecturers in the disciplines mentioned therein on regular basis and posted in the schools noted against each.

2. They shall draw their pay in Level 8 of the Pay Matrix plus usual allowances as admissible from time to time. They shall have the option to have their pay fixed as per proviso under FR 22(I)(a)(1), which must be exercised within one month from the date of issue of this Memorandum.
3. They are entitled for Transfer T.A./D.A and joining time.
4. They should report for duty before the Head of Institutions concerned **on or before 05.09.2025**, failing which it will be presumed that he/she has declined the offer and he/she will not be considered for promotion for a period of one year or next DPC whichever is later.
5. The Head of Institution/ Controlling Authority is requested to relieve the teacher within the stipulated date and furnish a compliance **report on or before 12.09.2025**.
6. No representation on whatsoever ground seeking extension of time beyond the prescribed joining date and/or change of place of posting will be entertained.
7. This promotion is subject to the outcome of the OA No. 797/2013 and MA. No. 227/2013 and O.A. No. 535/2013 in the Hon'ble Central Administrative Tribunal, Chennai Bench.
