He/She should report for duty before the Head of Institution/Controlling Authority concerned **on or before 17.08.2026, failing which it will be presumed that he/she has declined the offer and he/she will not be considered for promotion for a period of one year or next DPC, whichever is later.**

5. No leave should be granted at the time of relief. No request for retention or transfer to any other school will be entertained at any cost. The official should be relieved without waiting for substitute. The Head of Institution/Controlling Authority is requested to relieve the promotees within the stipulated date and submit a compliance **report on or before 31.08.2026.**
