On the basis of the recommendation of the Recruitment Committee, the undersigned hereby offers to Selvi. K.Januragavi, a temporary and regular appointment in the Post of Trained Graduate Teacher (Mathematics) (Group-B, Non-Gazetted) and posted in Rm.A.S.P.G.H.S., Karaikalmedu, Karaikal with immediate effect. The appointee will draw pay in Level-7 of the 7th pay Matrix corresponding to the Pre-revised Pay Band of PB-2 Rs. 9300 - 34800 + Grade Pay Rs.4600/- and also be entitled to draw the dearness and other allowances at the rates as admissible and subject to the conditions laid down in rules and orders governing the grant of such allowances in force from time to time.

2. The terms of appointment are as follows: -

- i. The appointment is purely temporary and may be terminated at any time by a month's notice given by either side without assigning any reasons. The Appointing Authority, however, reserves the right of terminating the services of the appointee forthwith or before the expiry of the stipulated period of notice by making payment to her of a sum equivalent to the pay and allowance for the period of notice or the unexpired portion thereof. In case the appointees prefer to terminate her service before the expiry of the stipulated period of notice, she shall be allowed to do so by making payment of a sum equivalent to the pay and allowances for the period of notice or unexpired portion thereof.
- ii. The candidate is liable to be transferred to any Government school in the Union Territory of Puducherry and should undertake to serve in the Government school, where posted, as the present place of posting is subject to change.
- iii. The appointee is further informed that who is posted / later transferred to outlying regions should serve for a minimum period of Five (5) years from the date of appointment/posting. Canvassing in any form for transfer will lead to cancellation of this offer of appointment.
- iv. The candidate who reports for duty should be placed on probation for a period of two years from the date of her joining duty.

- V. Other conditions of service will be governed by the relevant rules and orders in force from time to time;
- 3. The appointment will be further subject to:
 - i. Production of certificate of fitness from the Competent Medical Authority (R.M.O);
 - ii. Submission of declaration in the form enclosed (Annexure-I) and in the event of the candidate having more than one wife /husband living or being married to a person, having more than one wife/ husband living, the appointment will be subject to him/her being exempted from the enforcement of the restrictions in this behalf;
 - iii. Submission of attestation forms for verification of character and antecedents along with joining report;
- iv. Submission of declaration to the effect whether the candidate is serving or is under obligation to serve another Central Government Department / Other State Government or Public Authority.
- 4. In case it is found that she was guilty of misconduct involving moral turpitude, which would disqualify her for Government Service, or had suppressed any material fact relating to her conduct prior to entry into Government Service or if any declaration given or information furnished by the Candidate proves to be false, she will be liable to be discharged from service and such other action as Government may deem necessary.
- 5. The appointment is provisional and is subject to the educational qualification certificates from recognised university, caste/community and nativity/residence certificate being verified through proper channels in respect of the candidate selected and if the verification reveals that the claim to the certificate is false, her services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Bharatiya Nyaya Sanhita (BNS) for production of false certificate.
