## **MEMORANDUM**

Sub: DSE – Estt.II. – Offer of appointment to the post of Trained Graduate Teacher(Language) – Orders – Issued.

On the basis of the recommendation of the Recruitment Committee, the undersigned hereby offers to the candidates mentioned in the ANNEXURE-I to this Memorandum, a temporary and regular appointment in the post of Trained Graduate Teacher(Language) (Group-B, Non-Gazetted) in the language mentioned therein and posted in the schools indicated against each with immediate effect. The appointee will draw pay in the Level-7 of the Pay Matrix and also be entitled to draw the dearness and other allowances at the rates admissible and subject to the conditions laid down in rules and orders governing the grant of such allowances in force from time to time.

- 2. The terms of appointment are as follows: -
  - (i) The appointment is purely temporary and may be terminated at any time by a month's notice given by either side without assigning any reasons. The Appointing Authority, however, reserves the right of terminating the services of the appointee forthwith or before the expiry of the stipulated period of notice by making payment to him/her of a sum equivalent to the pay and allowances for the period of notice or the unexpired portion thereof. In case the appointee prefers to terminate his/her services before the expiry of the stipulated period of notice, he/she shall be allowed to do so by making payment of a sum equivalent to the pay and allowances for the period of notice or unexpired portion thereof.
  - (ii) The candidate is liable to be transferred to any institution / school in the Union Territory of Puducherry and should undertake to serve in the institution / school, where posted, as the present place of posting is subject to change after general transfer, if any, to be effected later through counseling based on seniority.
  - (iii) The appointee is further informed that those who are posted / or later transferred to outlying regions should serve for a minimum period of 5 years from the date of appointment / posting. Canvassing in any form for transfer will lead to cancellation of this offer of appointment.
  - (iv) The candidate who reports for duty should be placed on probation for a period of two years from the date of his/her joining duty.
  - (v) Other conditions of service will be governed by the relevant rules and orders in force from time to time.

- The appointment will be further subject to:-
  - (i) Production of Certificate of fitness from the Competent Medical Authority(R.M.O).
  - (ii) Submission of a declaration in the form enclosed (Annexure-II) and in the event of the candidate having more than one wife / husband living or being married to a person, having more than one wife / husband living, the appointment will be subject to him/her being exempted from the enforcement of the restrictions in this behalf.
  - (iii) Submission of attestation forms for verification of character and antecedents along with joining report.
  - (iv) Submission of declaration to the effect whether the candidate is serving or is under obligation to serve in Central Government Department / other State Government or Public Authority.
- 4. In case it is found that he/she was guilty of misconduct involving moral turpitude, which would disqualify him/her for Government Service, or had suppressed any material fact relating to his/her conduct prior to entry into Government Service or if any declaration given or information furnished by the candidate proves to be false, he/she will be liable to be discharged from service and such other action as Government may deem necessary.
- 5. As no person professing a religion different from the Hindu or Sikh religion can be deemed to be a member of Scheduled Caste, the candidate should inform about the change, if any, of his/her religion to his/her appointment /administrative authority immediately after such a change. (This applies only in the case of Scheduled Caste candidates).
- 6. The appointment is provisional and is subject to the educational qualification certificates and Caste / Community Certificate being verified through the proper channels in respect of the candidates selected and if the verification reveals that the claim to the certificate is false, his/her services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false certificate.
- 7. The Offer of Appointment is further subject to the outcome of the O.A.Nos.166/2024, 310/191/2024, 310/188/2024, 209/2024, 246/2024, 296/2024, 208/2024, 310/115/2024, 310/114/2024, 310/164/2024 and M.A.No.175/2024 filed in the Central Administrative Tribunal, Madras Bench, Chennai.





- 8. The Certificates / declarations should be produced to the Head of Office concerned at the time of reporting for duty.
- 9. If the candidate accepts the offer on the above terms and conditions, he/she should report for duty before the Head of Office concerned immediately and in any case **not later than 11.04.2025**. If the candidate fails to report for duty on or before the prescribed date the offer will be treated as cancelled, and no further communication will be entertained. No travelling allowance will be allowed for joining the post.
