**TENDER-cum-AUCTION NOTICE**

Sealed tenders are invited for disposal of **E-waste** items belonging to this Institution, in **"as-is-where-is"** condition.

2. The tenders in sealed cover should be addressed to "The Principal, Thanthai Periyar Govt. Girls Higher Secondary School, Ariyankuppam – 605 007", duly superscribed on the envelopes **"Tender for disposal of E-waste items"** and shall reach the Undersigned **on or before 06/01/2026 by 1.00 pm**. The received tenders will be opened on **the same day at 3.30 pm** in the presence of tenderers or their authorised representatives who are present at that time. If the scheduled date of tender / auction happens to be a public holiday, the date of opening of tenders will automatically be postponed to the next working day at the same time.

3. The tenderer should offer rate for **"the entire items as one lot"** in his tender. Public auction will be started from the highest rate quoted by the tenderers. The sale will be effected only to the highest bidder.

4. The tenderers should deposit an amount of Rs. 500/- (Rupees five hundred only) as Earnest Money Deposit (EMD) in cash. The EMD of the unsuccessful tenderers will be refunded immediately after the tender/auction sale is completed, whereas the EMD of successful tenderer will be returned only after the official process is completed in all aspects.

5. The following self-attested photocopy of documents / certificates must be enclosed along with the tenders, viz.,

- i) Valid GST Certificate
- ii) PAN card
- iii) Aadhar Card / Valid Family Ration Card / Valid Driving License.
- iv) Copy of valid Air Consent, Water Consent and E-Waste EPR registration certificate issued by the concerned State Pollution Control Board/CPCB.
- v) Copy of authorization / registration issued by the Central Pollution Control Board for recycling and
- vi) Letter nominating your representative, along with a copy of ID proof.

The tenders without the above-mentioned certificate / documents will be rejected.

6. Tenders received after the due date and time will not be entertained.
7. The Undersigned reserves all the rights to accept or reject any or all the tenders without assigning any reason, thereof. The decision of the undersigned is final in case of any dispute.
8. In the public auction, the tenderers who have submitted sealed tenders only will be allowed to participate.
9. The successful tenderer should pay the entire amount immediately after the tender and clear the items on the same day at his own risk and cost, failing which the EMD will be forfeited.
10. This office is not responsible for the safe custody of the articles once auctioned. No claim on the quantity of the unserviceable condemned articles will be admitted once the tender is finished.
