

Tenders in plain paper should be sealed and addressed to the Chief Educational Officer, Directorate of School Education, Puducherry duly superscribing on the envelope as "Condemned / unserviceable furniture and Equipments of the Audio Visual Education and Chief Educational Officer Office" and sent to reach the undersigned on or before **05/12/2018** at **10.30 AM**. The tender will be opened on the same day at **11.00 A.M.** in the presence of the tenderers who are present.
3. The intending tenders should deposit an amount of Rs.2,000/- (Rupees Two thousand only) as earnest money deposit. The earnest money deposit of the unsuccessful tenders will be returned immediately after tender is over.
4. Tenders received after the due date and time will be rejected.
5. The successful tenderer should pay the entire amount with GST and clear the items within 24 hours at his own risk and cost, failing which the earned money deposit will be forfeited.
6. The intending tenderers may inspect the condemned / unserviceable furniture and Equipments of the Audio Visual Education during Office hours on any working day with prior permission of the Officer Concerned, Office of Chief Educational Officer, Puducherry without any disturbance.
